We understand that CLI will issue an invoice for the product(s) under evaluation and shipping charges. CLI will ship via ground service, unless otherwise requested.

At the end of the evaluation, we shall either return the product(s) to CLI in whole and good condition in the same shipping container as it was received to CLI and disregard the CLI invoice, or we shall purchase the above product by paying the CLI invoice. We further understand that all returns must bear a duly authorized CLI return authorization number available upon request from CLI. We will be responsible for the return shipping charges. If the product(s) are returned, should American Express have been used to obtain the evaluation, a CLI company check will be issued in 3 - 4 weeks for the amount less 3% American Express fees.

If we, or any of our agents, cause any product damage due to negligence or mishandling, or if any product component (e.g. manuals, cables, diskettes, etc.) is not returned to CLI, we will assume full responsibility for the cost to repair or replace the missing or damaged accessory or product.

In the event that an extension of the product evaluation period is necessary, we agree to notify CLI at least 3 days prior to the expiration date of this evaluation. Grant of extensions shall be entirely at the discretion of CLI.
